# **Grisport Italy Promotion 2024**

# Prize terms and conditions.

#### **Promotional Period**

1.The Promotion commences at 12.01am on 1.04.2024 and closes at 11:59pm on 30.06.2024. Any purchases made outside the Promotional Period are ineligible.

#### Entry

- 2.To enter, each Eligible Entrant must, during the Promotional Period either:
- (a) Purchase any Grisport footwear product (excluding accessories and socks) in a single transaction from any official Grisport distributor\*.
- (b) Purchase any Grisport footwear product (excluding accessories and socks) in a single transaction in any official Grisport distributor and go to <a href="https://www.grisport.co.nz/register">www.grisport.co.nz/register</a>, input the requested details and submit the fully completed registration form online.
- 3. Eligible entry is open to New Zealand residents only. Employees (and their immediate families) of the Promoter and official distributor, its related entities and any agencies associated with this Promotion are ineligible to enter.
- 4. Entrants must retain the original receipt or invoice for their Qualifying Transaction as proof of purchase and produce this within 7 days of the draw by request of the Promoter. Failure to do so may, in the sole discretion of the Promoter, result in invalidation of the entrant's entry and forfeiture of any right to a prize.
- 5. Only 1 entry permitted per Qualifying Transaction. Each entry must be submitted separately.
- 6. Entry into this promotion is deemed as acceptance of these terms & conditions
  \*Official distributor is defined as a retail outlet supplied by The Promotor who is defined as either Bene Footwear NZ or Wholesale Boots
  NZ Ltd

#### **Draw**

- 7. The Draw will be conducted by the promoter, at the location of Wholesale Boots NZ Ltd, Pukekohe on Friday 19<sup>th</sup> of July 2024. The first valid entry randomly drawn is the Prize Winner who will win the Travel Prize, subsequent prizes will be drawn for additional prizes as outlined in point 24.
- 8. The Prize winners will be notified by phone or email address supplied on the submitted online registration and have one (1) month to make contact with The Promoter to claim the prize.
- 9. If there is a dispute as to the identity of an entrant, the Promoter may, in its sole discretion, determine the identity of the entrant.
- 10. The Promoter is not responsible for any notification that is misdirected, lost, or damaged or if the Prize winner cannot be contacted due to incorrect details provided.

# **Prize**

#### The Travel Prize

- 11. The Travel Prize is: A trip for two to Italy. The parameters of this prize are that it must:
  - (i) be booked via The Promoters designated travel agent, and,
  - (ii) include a trip for two people with Italy as a destination and accommodation within Italy,
  - (iii) cost no more than total \$15,000NZD. This includes up to \$3,000 spending money provided by the Promoter. If the travel costs exceed this total amount the additional cost is the responsibility of the Travel Prize winner.
- 12. The Travel Prize winner must be age 18 or over to claim the Travel Prize.
- 13.If the Travel Prize is unavailable, the Promoter in its absolute discretion, may substitute that Prize (or a component of the Prize) with a prize of equal value and/or specification up to \$15,000NZD. The Prizes is not exchangeable or transferable and is not redeemable for cash.
- 14. If, once the Travel Prize is awarded, the prize must be claimed within one (1) month of the draw and redeemed\*\* within three (3) months from date of notification. If for any reason the Winner does not take/redeem the Prize (or an element of the Prize) within three (3) months from notification, then the Prize (or that element of the Prize) will be forfeited. The Prizes must be taken

as described and no compensation will be payable if the Winner is unable to use the Prize as described

- 15. The Winner takes the Travel Prize entirely at his/her own risk and indemnifies Wholesale Boots NZ Ltd and Bene Footwear NZ in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the prize. The Winner is responsible for all insurance, tax or other costs that may be associated with the Prize. Where the Prize has associated terms and conditions the Winner accepts the Prize subject to those terms and conditions and restrictions. The Winner waives, surrenders, and relinquishes in favour of the Promoter and its related companies all claims of any nature howsoever arising (including as a result of negligence).
- 16. Where the Prize includes air travel and/or accommodation, either international or domestic (the 'Travel Prize'): (a)the Winner MUST have valid documentation, including but not limited to valid passports and Visas, which meet the requirements of immigration and other government authorities at every destination. (b) Any fines, penalties, payments, or expenditures incurred as a result of such documents not meeting the requirements of those authorities (including any costs associated with delay, will be the sole responsibility of the Winner). (c) The Winner and their travelling companion (if applicable) must always travel together.
- 17. The Winner is responsible for transport from their residence to their closest international airport for flight departure and from their international airport to their residence upon returning to New Zealand.
- 18. Flight tickets are available on the regular scheduled services of each airline and are subject to seasonal embargos. The flight itinerary may have to be adjusted depending on the airline's departure city, availability, and their current flight schedule. Unless otherwise specified, the air travel is economy class.
- 19. Any changes to travel dates or additional accommodation outside the travel period specified in the Travel Prize details, made by the winner, which incur additional costs, are to be paid by the Travel Prize winner.
- 20. Unless explicitly stated in the Rules, the Travel prize Winner will be responsible for expenses including, but not limited to, additional spending money, meals, drinks, transport, laundry charges, activities, incidentals, taxes (excluding departure and any other flight associated taxes included within the Travel Prize), gratuities, services charges, passports, visas, travel insurance and all other ancillary costs associated with redeeming the Travel Prize.
- The Winner must obtain travel insurance to protect themselves against additional costs incurred in the event of unforeseen circumstances.
- 21. The Travel Prize is not transferable or exchangeable and cannot be redeemed for cash. The Travel Prize must be taken as stated in the Specific Rules and no compensation will be payable if the Winner is unable to use the Travel Prize as stated. For the avoidance of doubt, if the Winner is, for whatever reason, unable to travel on a nominated date during this period, whether the failure was due to reasons beyond the Winner's control or otherwise, then the Winner will forfeit the Travel Prize.
- 22. The Promoter makes no representation as to availability, safety, conditions and other issues that may exist at any destination. International travel advice can be obtained from various sources, including government, local consular offices and the web site of the New Zealand Ministry of Foreign Affairs and Trade. The winner accepts the Travel Prize at their own risk.
- 23. All travel is subject to the terms, conditions, and restrictions of the Travel Prize service providers. Any travelling companion included in the Travel Prize (if applicable) accepts the Travel Prize subject to these terms, conditions, and restrictions as if references to the Winner in the relevant clauses were to the travelling companion. The Winner and their travelling companion must sign a legal release, in a form acceptable to the Promoter in its absolute discretion, if requested by the Promoter.

# Other Prizes

- 24. Prizes for the entries drawn after The Travel prize are eligible for one only entry per prize. Other prizes drawn are eligible one item per entry as follows:

- 5 x Pairs of Grisport Footwear valued from \$200.00 each

The Prizes are not exchangeable or transferable and are not redeemable for cash.

#### **Notification of Winners**

- 25. The Winners will be notified by email or by telephone within 2 days of the Draw. Their names may also be published on social media for Grisport NZ.
- 26. The Winners must claim their respective Prize within one (1) month of the Draw.
- 27. If a Winner cannot be contacted, the Promoter will retain their Prize for one (1) month from the date of the Draw. If the Prize is not claimed within this time, the Promoter will re-draw another winner for the unclaimed Prize on the  $19^{th}$  of August 2024, by way of a random draw (Re-draw).
- 28. The Winners of the Re-draw will be contacted in writing and by telephone within 2 days of the Re-draw. Their name may also be published on social media for Grisport NZ and an Official distributor of Grisport Footwear. Winners of Re-drawn Prizes must claim their respective Prize within one (1) month of the Re-draw.
- 29. The individual Prize will be delivered free of charge to the winner or the store of which the Grisport product was purchased for collection by the Winner (or Re-draw winner). Delivery will be within 28 days of the draw (or Re-draw).

# Privacy

- 30. The Promoter will collect, use, and disclose entrants' personal information to conduct and manage the Promotion in accordance with its Privacy Policy. The Promoter may also, with the entrants' consent, use entrants' personal information for promotional, marketing, publicity, research, and profiling purposes for any of the Promoter's products, including sending electronic messages to, or telephoning, any entrant.
- 31. Entrants consent to the Promoter and Official distributors' using their name, likeness, image and/or voice in the event they are a Winner (including photograph, film and/or recording of same) in any media for an unlimited period without remuneration for the purpose of promoting the Promotion and any of the Promoter's products.

### General

- 32. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated for any reason beyond the control of the Promoter including technical difficulties, unauthorised intervention or fraud, the Promoter may, to the extent permitted by law: (a) disqualify any entrant; or (b) subject to any written directions from a regulatory authority, modify, suspend, terminate or cancel the Promotion or modify the Prize, as appropriate.
- 33. Except for the Non-Excludable Guarantees and any other liability that cannot by law be excluded, the Promoter (including its respective distributors, employees and agents) will not be responsible and excludes all liability (including negligence) for any personal injury or loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of: (a) the Promotion and/or the taking or use of the Prize; (b) any technical difficulties or equipment malfunction outside of the Promoter's control; (c) any theft, unauthorised access or third party interference; (d) any late, lost, altered or misdirected entries due to any reason beyond the Promoter's control; (e) any tax liability incurred by a Winner or entrant; and/or (f) any damage to or delay in transit of the Prize during delivery, except to the extent caused or contributed to by the Promoter.
